#### From the President: Kenneth Bob



Welcome to the inaugural issue of the Ameinu newsletter, *Olameinu*. The name means "our world" in Hebrew and we hope to use this venue to share

information on our local and national activity with our members and supporters.

In reviewing the content in this issue, I am struck by the broad range of our ongoing educational, advocacy and charitable activity. Highlights include our demonstration in Annapolis in support of the Israeli-Palestinian peace talks, our contribution for a library in a community center in a Negev Bedouin village and our campaign against inhumane labor practices by the leading kosher meat manufacturer in this country.

You will also find items which represent our response to recent studies regarding the drop in identification with Israel and Jewish identity among the younger generation. Ameinu has programmatic initiatives to address this challenge, including support for Habonim Dror, the Zionist youth movement, and the Union of Progressive Zionists campus network, as well as our Israel mission specifically for people in the 27-40 age range.

#### Ameinu Takes on Agriprocessors by Brad Rothschild

Ameinu's commitment to social and economic justice has found expression in its recent actions in response to firsthand accounts of mistreatment of workers at the Agriprocessors kosher meat facility in Postville, Iowa.

Agriprocessors is the largest kosher slaughterhouse in the US, claiming to provide sixty percent of the beef and forty percent of the chicken to the domestic kosher market. In May 2008, federal agents arrested nearly 400 Agriprocessors employees—about two-thirds of all employees at the plant—charging them, among other infractions, with immigration violations and identity theft.

At the May Ameinu board meeting, Avram Lyon, an Ameinu board member and a consultant for the meatpacking union United Food and Commercial Workers,



presented a shocking eyewitness account of the events in Postville. Lyon described the abuses that the company has inflicted on its employees—the dangerous work environment, the sexual harassment, and the hiring of underage workers. He also told of the government's harsh response—the detainment of the immigrant workers without thought for the families left behind with no means of support, and the intended deportation of the workers following the completion of their prison sentences.

Following Lyon's testimony, the organization took action. On June 16, 2008, Ameinu issued a statement calling on its members and on all Jewish organizations to refrain from buying any of the Agriprocessors brands of kosher meat. In the statement, Kenneth Bob, Ameinu President said that "It's unfathomable that a company devoted to selling glatt kosher meat can be so inhumane to the people working for it. The entire Jewish community should stand up and say, 'enough.' Mistreatment of employees goes against our heritage, our religion, and our conscience." Early response to the call to action has been positive, and the statement has been picked up by the Jewish press in the US and Israel.

Also in June, Congregation Ansche Chesed on New York's Upper West Side hosted a talk by Avi Lyon entitled, "When is Kosher Meat Treif? A First-hand Account of the Agriprocessors Meat Packing Story." A rapt audience listened as Lyon recounted his experience. Lyon rhetorically asked the crowd, "How can this be kosher?" The Q & A session that followed was deeply impassioned, with audience members wondering why the bodies that certify kashrut have not revoked their hechsher from Agriprocessors. Ameinu is wondering the same and hopes that the Jewish community will stand together to demand that Agriprocessors change its ways.

You're never too old to change! At least this is what students from across the country will tell Israel this summer, as the culmination of the Union of Progressive Zionists' (UPZ) spring campaign, when student representatives deliver approximately 500 birthday cards to the Israeli Embassy in Washington, D.C. The birthday cards wish Israel a happy 60th birthday, and call for a freeze to settlement expansion as a necessary step towards another 60 years in peace and security.

The UPZ, of which Ameinu is one of four founding organizations, is a national network of student activists who advocate and educate for peace and social justice in Israel and Palestine. UPZ students planned and implemented this campaign in order to send a message to the Israeli government, and educate their peers on campus about the dangers to Israel's existence caused by settlements and a decades-old occupation.

As part of this campaign, the UPZ hosted Hagit Ofran of Peace Now's Settlement Watch for a 2-week, 11-campus speaking tour this past April. Ms. Ofran spoke about her experience monitoring the illegal growth of settlements in the West Bank and the impact this expansion has on the U.S.brokered peace negotiations.

The UPZ looks forward to becoming an even louder voice this fall!


# Book Review: A Pigeon and a Boy by Meir Shalev Review written by Fran Assa

If the following quote appeals to you, you'll love A Pigeon and a Boy:

And what he saw then, he never saw again after. The children especially going to school, the bluish doves flying down from the roofs to the pavement, and the little loaves covered with flour, thrust out by an unseen hand, touched him.

It's taken from Tolstoy's *Anna Karenina*, and it is the kind of writing that resonates throughout the new English translation of Meir Shalev's recent work.

The book begins with a flashback to the 1948 War of Independence in which Palmach fighters, trying to aid the besieged Jews of Jerusalem, come under heavy Arab fire. In the midst of the carnage, a homing pigeon is suddenly released and soars aloft, causing astounded



The pigeon is central both to the plot and form of the novel. From the opening chapter, the story unfolds like a Bach fugue, journeying gracefully back and forth in time as we go from the War of Independence to Yair's internal struggle for independence and his discovery that the key to understanding himself can be found in that battle.

In most of the chapters, Yair addresses his dying or dead mother. Never at ease in either his childhood or his married home, like the emblematic homing pigeon, Yair yearns for a home of his own. Midway through the book he takes steps toward rebuilding his life by building his dream home. In reality it is his girlfriend, the contractor, who does the building.

Shalev's writing, like Tolstoy's, is visceral. We experience the night sky, the cries of jackals, the rustling of wings and leaves, and especially the bird life of Israel. We experience these things much as we would in reading Tanach, its pages filled with references to the landscape and nature, and with naturalistic poetry.


Indeed there is scarcely a page that does not in some way resonate to the Bible. Like the Tanach, the book abounds with motifs of doves, barrenness, and fecundity: Abraham, who made an offering of doves, and of course the dove that appears in the story of Noah, who is seeking a home on which to land his ark. The house that Yair needs for his emotional survival is like the ark, and the description of its construction is as detailed as that of the ark. As in Genesis, Yair and his girlfriend attempt to build their own Gan Eden where they can start anew, naked as Adam and Eve, "... and nobody's going to drive us out of here," she says.

There is also Greek and Christian imagery. Yair is the antithesis of Odysseus, but both of them, like homing pigeons, yearn to return to their real home. In Christian art, the Holy Spirit is shown as a dove that descends amidst beams of light onto Mary in paintings which tell of the annunciation of Jesus' mysterious birth. Yair's birth is the mystery of this story.

There is a magical element to the storytelling, as there is to a great deal of Yiddish and Hebrew literature. After all, before Mickey Mouse or Donald Duck, there was already a talking snake.

My biggest criticism of this lovely book is that the women have a tendency to sound like prophetesses. This is probably intentional, but after a while it can be a bit grating.

Evan Fallenberg's translation is as literary as the original, rhythmic and richly vivid. *A Pigeon and A Boy* was originally published in 2006 in Hebrew as *Yona V'naar* by Am Oved Publishers Ltd., Tel Aviv and is published in English by Random House, Inc., New York.





# Ameinu Establishes Library in Bedouin Community Educational Activity Center

Children of all ages in the Bedouin villages of the Negev lack basic provisions for play and recreation – both within their homes and in the community. In response to these needs, NISPED initiated the *Community Educational Activity Center Program*, establishing centers in two villages, Hashem Zanah and Qasser al Sir. Ameinu's Los Angeles members have joined the effort, raising money to establish a library as part of this center.



Qasser al Sir, with a population of some 3,000, is one of the largest Bedouin villages. Although incorporated into the *Abu Basma Regional Council*, and hence an officially recognized village, its municipal infrastructure is so rudimentary that for all intents and purposes it is not that different from 'unrecognized' villages.

The Center was constructed on land donated by the village, and consists of a well-equipped playground, playing fields, and a building for indoor activities. The program is designed to meet the needs of children of all ages: from a play group for toddlers and their mothers to organized activities and sports for school-aged children. The program is locally staffed, with training

provided by NISPED. A group of high school students from the community is being trained as junior counselors who will conduct after-school activities for the younger schoolchildren.

The Center is located near one of the two schools serving the community. As is the case in most of the schools in the Bedouin community, it has no library—so that in effect, schoolchildren have no contact with the world of books, with the exception of their textbooks.

With the help of the Los Angeles branch of Ameinu, NISPED will establish a lending library of 300-400 books in the *Community Educational Activity Center* in Qasser al Sir. The grand opening of the library will include various community activities encouraging a love of reading and books, such as workshops where participants will write and produce their own books, relating their personal and their community's stories.

# Ameinu Launches Online Educational Video Campaign

Ameinu, working with Chaim Yavin, Israel's foremost newscaster, have distilled his five-hour miniseries, "The Land of the Settlers," into a 90-minute DVD. This new DVD, available for the first time, explores the tensions, emotions, and too-frequent violent conflicts of the Palestinians and Israeli settlers living on the West Bank.

In order to realize the objectives of Zionism – to live as a normal people in a Jewish state guided by the prophetic principles of justice – Israel must reach an agreement with the Palestinians on a two state solution. Such an agreement

must guarantee security for Israel and create the opportunity for economic viability for the Palestinians. The situation on the ground today, the strident voices of extremists on both sides of the divide, keep us from moving toward that goal.

To raise the level of pro-peace, pro-Israel concern in America, Ameinu has extracted four trailers from the DVD and is rolling them out on the internet. It is our hope that these trailers and the DVD they come from will add to the understanding of the need for progress for the future, to protect the lives and the safety of everyone involved.
